

CSUWA Through the Years

Mary Green was born in Mexico on the 6th of September, 1887. No information about her early years could be located. At some point in her youth, she moved to Missouri, where she later attended a business college in Columbia, Missouri. She worked as a secretary and receptionist after graduation. Mary married Roy M Green on May 4, 1915 in Columbia, Missouri. Mary and Roy had four children: Dorothy, Mary, Roy, and Russ. The family moved to Fort Collins, Colorado in 1940 when Roy accepted the position of President of then Colorado State College of Agriculture and Mechanic Arts. Mary was a member of the United Methodist Church, Daughters of the American Revolution, as well as the CSCA&MA Women's Association, where she served as the 34th President from 1945-1946. Roy Green passed away in January of 1948 at the age of 58. After his death, a residence hall was constructed on the college campus in honor of Roy Green. On October 16, 1954, the new hall was dedicated during Homecoming. Mary Green attended the dedication of the \$1.3 million residence hall. No information about Mary's later years or death could be located.
