Accomplishments and Goals of Larimer County Commissioners Topic of November CSUWA Meeting

At the November meeting of CSUWA, **Larimer County Commissioner Kristin Stephens** will present **Larimer County Commissioners: Accomplishments and Goals**

Commissioner Stephens will discuss some of the recent successes of the Board of County Commissioners, including: strengthening Larimer County's Oil and Gas regulations; revising Larimer County's Land Use Code; creating a new Equity, Diversity, and Inclusion Board; and moving forward with Larimer County's Climate Action plan. Kristin will also discuss goals for the upcoming year, including: working with mobile home parks on zoning issues; operationalizing Larimer County's Climate Action plan; working on affordable housing, childcare, and homelessness; and collaborating with regional partners on how to spend Larimer County's American Rescue Plan dollars.

Kristin Stephens became a Larimer County Commissioner for District II in January 2021. She served as a City of Fort Collins City Council member from 2015 to 2021, and served as Mayor Pro Tem from 2019 to 2021. Kristin received her B.A. Degree in History from Colorado State University.

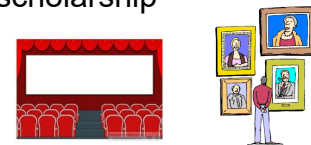
Creative Cards Interest Group

What the CSU Women's Association Means to Me

Becoming a part of the CSUWA helped me adjust to my new home, to learn about the university and our city, and to meet women who over the years have become life-long friends. I particularly loved meeting people from many departments across the university.

When Brent and I moved to Fort Collins in 1966 the University had about 12,000 enrolled students. Colorado State was the main employer in our community. There was very little growth south of Prospect. So hard to imagine now! I wish I had photos or videos of our community back then.

The CSU Women's Association was a very important organization for faculty wives, and I joined very soon after we moved here. It seemed that almost every faculty wife was a member. Many women back then did not have their own careers. Meetings were held on the CSU campus. There were not the parking problems that we now experience.

There were many Interest Groups, and they were so important to my feeling of belonging in this brand-new place. Since I grew up in the South and had never lived in the West, I really enjoyed the Western Literature Interest Group and remember how much fun it was to learn about the Rocky Mountain region. The author Wallace Stegner was a favorite of mine and opened my eyes to the beauty of this part of the country. I still remember reading Death Comes for the Archbishop by Willa Cather and wanting to visit Santa Fe as soon as possible after reading it and still love going there.

The Gourmet Group has been a wonderful part of my life for decades. Once I began representing Fort Collins in the Colorado General Assembly in 1983, I could not attend our monthly meetings. I remained a member for the twenty years I was in Denver; the dues were modest and helped students financially. Despite my other commitments, I could still be a part of the Gourmet Interest Group. Spouses were included, and we met on the weekends so I could participate. That kept me connected to the CSU Women's Association through the years. Members are from varied departments across the campus and that leads to interesting conversations. Despite COVID we have continued to meet on Zoom although we can't share excellent dinners and wine in person. We have to depend on our imaginations.

Education has been central to the CSU Women's Association, and I love that we can band together and support scholarships for students year after year. That is one more powerful reason that the CSU Women's Association means a lot to me.

CSUWA Through the Years

“Carrie Richards was a “vivacious and appealing classmate” of Charles Lory and in 1898 the two graduated together from the State Normal School at Greeley, Colorado (now the University of Northern Colorado). Six years later in 1940 they were married. They had one daughter. Carrie Lory was an excellent helpmate for Charles Lory during the thirty-one years that he was president of the State [Colorado] Agricultural College (CAC). “Her own qualities of leadership and personal warmth did much to encourage a productive relationship between the college and the community that it served.”

Carrie Lory was also the instigator of the Loan Fund for needy college students. The fund enabled women and later men to finish their education. She maintained records of those who had repaid their loans and those loans which were still outstanding. In 1941 the name of the Women’s Association Loan Fund became the Carrie R. Lory Loan Fund. Carrie Lory administered the loan fund for twenty-nine years.”

Carrie Richards Lory, served as the second President of the Colorado Agricultural College Women’s Association (now Colorado State University Women’s Association) from 1913-1914. Carrie Richards Lory passed away in 1948.

Thanksgiving Day History



- Over the past several centuries, Thanksgiving in the United States has been observed on differing dates. From the time of the Founding Fathers until the time of Abraham Lincoln, the date of observance varied from state to state.
- By the beginning of the 19th century, the last Thursday in November had become the customary date in most states of the United States of America... coinciding with (and eventually superseding) Evacuation Day (the day commemorating the day the British exited the United States after the Revolutionary War).
- Thanks to the persistence of a woman named **Sarah Josepha Hale**, Abraham Lincoln in 1863 proclaimed that Thanksgiving Day would be celebrated on the LAST Thursday in November for all states. For over four decades, **Sarah Josepha Hale** had written letters to numerous politicians advocating for an official Thanksgiving Day holiday! Lincoln established the national Thanksgiving Day explicitly for celebration of the “bounties that had continued to fall on the Union and for the military successes in the war”, and in “humble penitence for our national perverseness and disobedience”. However, because of the ongoing Civil War, nationwide Thanksgiving Day celebrations did not occur until Reconstruction was completed in the 1870s.
- Seventy-six years after Lincoln’s proclamation, on the 31st of October in 1939, President Franklin D. Roosevelt signed a presidential proclamation changing the holiday to the NEXT TO THE LAST Thursday in November, for “business reasons”. And later, on the 26th of December in 1941, Roosevelt signed a joint resolution of Congress changing the national Thanksgiving Day to the FOURTH Thursday in November.
